  Admission secured on the basis of any wrong certificate shall be cancelled by the Principal forthwith and no appeal against such action of the Principal shall be entertained.

#### ■ CATEGORIES PRIORITIES IN ADMISSION

The following priorities shall be followed in granting admissions: -

**Category 1-.** Children of transferable and non-transferable **Central government regular employees and children of ex- servicemen**. This will also include children of Foreign National officials, who come on deputation or transfer to India on invitation by Govt. of India.

**Category 2-.** Children of transferable and non-transferable employees of Autonomous Bodies / Public Sector Undertaking/Institute of Higher Learning of the Government of India. Include **Nationalised & Public sector Banks**, **LIC,BSNL,MTNL**, **ONGC**, **AIR**, **Doordarshan** etc.

**Category 3-.** Children of transferable and non-transferable **State Government regular employees.** 

**Category 4-.** Children of transferable and non-transferable employees of Autonomous Bodies / Public Sector Undertaking/Institute of Higher Learning of the State Government ( **Govt. Autonomous college**)

Category 5-. Children from any other category including Private Banks, Business, construction Workers, any other private jobs etc.

Note: Preference in Admission to wards will be based on the number of transfers of the parents in the last 7 years.

### ■ RESERVATION OF SEATS FOR ADMISSION IN CLASS I

The reservation norms shall be applicable within approved class strength 40 students per section

RTE 25%: 10 seats SC 15%: 06 seats ST 7.5%: 03 seats OBC 27%: 11 seats

DA (Differently -abled) 3%: 01 seat reserved horizontally
